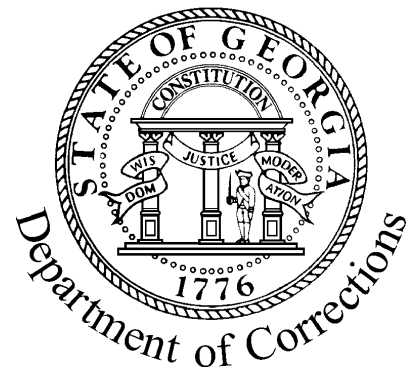

## Changes to UDS Population 1999

The Georgia Department of Corrections had 128 death sentence cases as of January 1, 2000. One hundred and twenty-five (125) inmates were legally under death sentence (UDS). This number includes those at the Georgia Diagnostic & Classification Prison, Georgia State Prison or Metro State Prison and those who are out to court but still under death sentence. There is 1 death sentence inmate whose sentence and/or convictions have been overturned but who has not been resentenced. There is 1 inmate who had been granted relief on his death sentence but judgement was later reversed by the Georgia Supreme Court. There is 1 death sentence inmate who has been sentenced to death but has not yet been released for transfer from the county jail to death row. There are 2 inmates whose death sentences have been resentenced to Life without Parole. These inmates may stay in this "legal limbo" for several years as their cases move through the courts. Some of these "legal limbo" cases have been moved to Georgia State Prison.

During 1999, the following changes were made to the UDS population:

- 8 new inmates were added.
- 1 inmate was removed from the UDS count due to natural death.
- 1 inmate has not been released from the custody of the county to the state.
- 2 inmates were removed from the UDS count due to resentencing.
- 1 inmate was removed from the UDS count due to their sentences being reversed, although they have not been tried or resentenced.

The following tables give the names of those UDS inmates and former UDS inmates who changed legal status in 1999.

Under Georgia law, there are three offenses that are punishable by death. Those crimes are murder, rape, and kidnapping. Of the 128 currently under death sentence, 127 were convicted of murder and one was convicted of kidnapping. There are currently 66 (53%) white men and 61 (47%) black men under death sentence. There is one white female on death row at Metro State Prison. Thirty-one percent serving time on death row report a high school education, and fifteen percent report some college. Fifty-one percent of these inmates report living with both parents during childhood.

Of the 107 inmates that reported employment status at the time of incarceration, 46% were employed at the time of arrest. Forty-nine percent of the active death row inmates are single with an average of two children. When looking at prior incarcerations, 69% of the active UDS inmates have no prior incarcerations. Muscogee County is the county with the highest number of convictions on death row, followed by Cobb and Douglas counties.
